

GENERAL TERMS AND CONDITIONS

TERMS AND CONDITIONS GOVERNING THE USE OF OPTIMA INSURANCE BROKER'S WEBSITE BY VISITORS AND REGISTERED USERS

The Terms and Conditions mentioned below form a contract and agreement between Visitor / Registered User and Optima Insurance Brokers Pvt. Ltd. and are for use of the website, as specified herein, by Visitors and Registered Users.

1. GENERAL

In this document the following words and phrases have the meanings set opposite them unless the context indicates otherwise. Visitor or Registered User in masculine gender shall be deemed to include the feminine gender and singular includes plural and vice versa and the word "includes" should to be construed as "without limitation".

2. DEFINITIONS

(i) "Bank Account" means the Registered User's bank account with a bank recognized and acceptable to Optima Insurance Brokers Pvt. Ltd.. The bank account may either be a current account, savings account, fixed deposit, term deposit or any other account facilities that any approved or nationalized Bank may offer from time to time.

(ii) "Call Center" means the call center set up by Optima Insurance Brokers (Pvt.) Ltd. to assist and help the Registered Users in case they face any difficulty while operating the website

(iii) "Intellectual property" means and includes any design, trade mark, logo, text, content, photographs, video, audio, graphics, slogans and service marks contained in the website

(iv) "Optima Insurance Brokers Pvt. Ltd." means a company incorporated under the Companies Act, 1956 and registered with IRDA as Insurance Broker (Direct) Regn. No. DB/326 having its registered office at B – 10, Greater Kailash Enclave, New Delhi – 110048, India and shall include its successors and/or assigns. Any Affiliate of Optima Insurance Brokers Pvt. Ltd. shall mean and include any company which is the holding or subsidiary company of Optima Insurance Brokers Pvt. Ltd. or a person under the control of or under common control with Optima Insurance Brokers Pvt. Ltd. or any person, in which Optima Insurance Brokers Pvt. Ltd. has a direct or beneficial interest or control in 26% or more of the voting securities of such person.

(v) "Person" means a company, corporation, a partnership, trust or any other entity or organization or other body whatsoever.

(vi) "Policy" means the various general insurance policies of various Insurance companies that Optima Insurance Brokers Pvt. Ltd. may introduce in their website from time to time.

(vii) "Policy Holder" means a person who purchases a Policy from Optima Insurance Brokers Pvt. Ltd. through its website or otherwise.

(viii) "Registered User" means a user registered with the website

(ix) "Registered User Password" means the password or any other authentication device or proof provided by Optima Insurance Brokers Pvt. Ltd. to the Registered User to enable him to successfully log on to the website.

(x) "Registered User Transaction Password" means the password or any other authentication device or proof provided by Optima Insurance Brokers Pvt. Ltd. to the Registered User to enable him to successfully transact on the website.

(xi) "Visitor" means any person having access to or visiting the website and is not a Registered User

(xii) "Website" means www.click2insure.in which offers a wide range of safe online services relating to the insurance sector.

3. TERMS OF USAGE

By accessing the website the Visitor and the Registered User acknowledges and accepts these Terms and Conditions.

(i) The website is deemed to be in use when it is loaded in temporary or permanent memory of the Computer of the Registered User or the Visitor. Optima Insurance Brokers (Pvt.) Ltd. and its personnel reserve the right to deny to Registered User or the Visitor at their sole discretion, access to the website including any portion thereof, without any prior notice.

(ii) The information and guidance provided in the website does not constitute a recommendation or solicitation by Optima Insurance Brokers Pvt. Ltd. or any of its personnel to buy any policies as mentioned therein. Any decision by the Visitor or the Registered of the policies / products should be based solely on their own evaluation as per their need and requirement. While Optima Insurance Brokers Pvt. Ltd. and its personnel have taken adequate care to ensure completeness, accuracy, transparency etc. of the information/services available and provided on the website, neither Optima Insurance Brokers Pvt. Ltd. nor any of its personnel shall be anyway liable for any loss or damage caused to a Visitor / Registered User claiming that they had suffered loss or damage as a result of putting reliance on information obtained through the website and acted thereon. It is the sole responsibility of the Visitor/ Registered User to evaluate the completeness, accuracy or usefulness of any opinion, guidance or other content made available on the website and Optima Insurance Brokers Pvt. Ltd. claims no responsibility for the same.

(iii) Optima Insurance Brokers Pvt. Ltd. shall issue a Registered User Password to all the registered users of the website. The Registered User will be able to access the services of the website by using his Registered User Identification and Registered User Password. The Registered User shall be able to successfully log on to the website by using his Registered User Password and access the services provided by the website which require authentication procedures. The Registered User by using the Registered User Identification and Registered User Password will be able to authorise transactions on the website. Apart from the Registered User Identification and Registered User Password the Registered User may also be provided with

a Registered User Transaction Password which will enable the Registered User to carry out such transactions on the website as may be specified from time to time. The Registered User would not be able to carry out the transactions without the use of the Registered User Transaction Password. The terms governing the Registered User Identification, Registered User Password and Registered Transaction Password are as follows :

(a) The Registered User confirms and agrees that he will be the sole and exclusive owner and is the only authorised user of the Registered User Identification and the Registered User Password and the Registered User Transaction Password and accepts sole responsibility for use, confidentiality and protection of the same. The Registered User shall never reveal the Registered User Transaction Password to a third party in any form whatsoever, oral, written or electronic.

(b) The Registered User irrevocably and unconditionally authorizes Optima Insurance Brokers Pvt. Ltd. to carry out his instructions, effecting such transactions as may be permitted by Optima Insurance Brokers Pvt. Ltd. from time to time, in accordance with these Terms and Conditions and such other terms as may be specified by Optima Insurance Brokers Pvt. Ltd. from time to time. Optima Insurance Brokers Pvt. Ltd. shall have no obligation to verify the authenticity of any authorised transaction effected by the Registered User by using his Registered User Password and the Registered User Transaction Password.

(c) Any transaction authorised by using the Registered User Identification, Registered User Password and the Registered User Transaction Password is deemed to be that of the Registered User and Optima Insurance Brokers Pvt. Ltd. shall not be responsible for any mistake / error made by the Registered User as to the nature of the transaction. Optima Insurance Brokers Pvt. Ltd. in its discretion is entitled to seek confirmation from the Registered User regarding any transaction undertaken by him.

(d) Any change of the Registered User Password and the Registered User Transaction Password on any account whatsoever shall be possible only by sending a written request by Registered Post to Optima Insurance Brokers Pvt. Ltd. at the address given above or by notifying at the indicated telephone number of the Call Centre. On the receipt of such a request within a reasonable time a new Registered User Password and a new Registered User Transaction Password shall be generated and provided to the Registered User. For generating the new password the Registered User may be required to submit such documents as are necessary for proper verification of the identity of the Registered User. However, Optima Insurance Brokers Pvt. Ltd. shall not be responsible and liable for any transactions that are carried out by the misuse of the earlier Registered User Identification, Registered User Password and the Registered User Transaction Password till the time of discontinuation of the earlier Registered Identification, Registered User Password and the Registered User Transaction Password on any account whatsoever.

(e) If any third party gains access to the services offered on the website through the use of the Registered User Identification, Registered User Password and the Registered User Transaction Password, the Registered User shall be deemed to be responsible for the acts committed thereof by the third party and the Registered User hereby indemnifies and holds harmless Optima Insurance Brokers Pvt. Ltd. against any liability, costs or damages arising out of claims or suits by or against such third parties based upon or relating to such access and use. Registered User also indemnifies and holds harmless Optima Insurance Brokers Pvt. Ltd. against any liability, costs or damages arising out of claims or suits brought by the Registered User for any loss or damage caused to him on account of the above.

(f) In case the Registered User becomes aware of any loss, theft or unauthorized usage of his Registered User Identification, Registered User Password and the Registered User Transaction Password, he shall immediately notify Optima Insurance Brokers Pvt. Ltd. in writing by Registered Post at the address given above or by notifying at the indicated telephone number

of the Call Centre of the same. Registered User also indemnifies and holds harmless Optima Insurance Brokers Pvt. Ltd. against any liability, costs or damages arising out of claims or suits brought by the Registered User for any loss or damage caused to him on account of the above.

(iv) Subject to the Terms and conditions mentioned herein, Optima Insurance Brokers Pvt. Ltd. shall take reasonable care to ensure the security of and to prevent unauthorized access to the services, which are part of the website using technology reasonably available to Optima Insurance Brokers Pvt. Ltd. at that point of time.

(v) Optima Insurance Brokers Pvt. Ltd. maintains own records of transactions transacted on the website through the computer systems or otherwise. Such records maintained by Optima Insurance Brokers Pvt. Ltd. from time to time shall be accepted as conclusive and binding for all purposes. More particularly, the record of Optima Insurance Brokers Pvt. Ltd. generated by the transaction(s), including the recording of the time of the transaction(s), shall be conclusive proof of the genuineness and accuracy of such transactions.

(vi) Software or information (if any) that is made available to download from this website is the copyrighted work of Optima Insurance Brokers Pvt. Ltd. and/or its suppliers. The use of the Software or information is governed by the terms of the end user license agreement, if any, which accompanies or is included in the Software. The Registered User and the Visitor shall not install or use any Software that is accompanied by or includes a License Agreement unless the terms and conditions of the License Agreement are agreed to.

4. RESTRICTION ON USE

(i) Registered User and or the Visitor agrees not to use the website in any manner inconsistent with these Terms and Conditions and for no other purpose.

(ii) Registered User and or the Visitor agrees to use the website only for personal use.

(iii) Registered User and or the Visitor agrees not to use the website contrary to law and for any illegal purpose.

(iv) The contents of the website constitute intellectual property of Optima Insurance Brokers Pvt. Ltd. and the contents and the information contained therein shall not be transmitted, transferred by the Registered User or the Visitor. The Registered User and the Visitor agree to protect the proprietary rights of Optima Insurance Brokers Pvt. and others having rights in the website or its content during and after the term of this Agreement. Any violation of the intellectual property right of Optima Insurance Brokers Pvt. Ltd. will give a right to Optima Insurance Brokers Pvt. Ltd. to claim damages, costs and forthwith cessation of the infringement of the said intellectual property right. This will not bar Optima Insurance Brokers Pvt. Ltd. from initiating criminal prosecution against the offender. The Registered User and Visitor agrees and acknowledges that all the intellectual property in the website vests and continues to vest with Optima Insurance Brokers Pvt. Ltd. only.

(v) The services and contents of the website which includes the contents, text, graphic, photographs, video and audio are either the property of, or used with permission by, Optima Insurance Brokers Pvt. Ltd. and are protected by applicable intellectual property laws of India and other countries and or international treaties. The trademarks, logos, slogans and service marks displayed on the website, are registered and unregistered trademarks of Optima Insurance Brokers Pvt. Ltd. and others.

(vi) Nothing contained on the website should be construed as granting, by implication, estoppel, or otherwise, any license or right to use any Trademark, design, information (which may constitute copyright) or any other intellectual property displayed on the website without the prior written permission of Optima Insurance Brokers Pvt. Ltd. or such third party that may own the Trademark, design, information (which may constitute copyright) displayed on the website. Any misuse of the Trademark, design, information (which may constitute copyright) displayed on the website, or any other content on the website, except as provided in these Terms and Conditions, is strictly prohibited. The Registered User and the Visitor agrees not to misuse or violate the intellectual property of Optima Insurance Brokers Pvt. Ltd or of any other person as contained and displayed in the website save and except provided in these Terms and Conditions.

(vii) The contents of the website may include trade secrets of Optima Insurance Brokers Pvt. and others. The Registered User and the Visitor agree to protect the trade secrets of Optima Insurance Brokers Pvt. and others having rights in the website or its content during and after the term of this agreement and to comply with all reasonable written requests made by Optima Insurance Brokers Pvt. or its suppliers of content, equipment or otherwise to protect their and others' contractual, statutory and common law rights in the website.

(viii) The Registered User and the Visitor agree to notify Optima Insurance Brokers Pvt. in writing promptly upon becoming aware of any unauthorized access or use of the website by any party or of any claim that the website infringes upon any copyright, trademark or other contractual, statutory or common law rights.

(ix) The Registered User and the visitor agree to only download and retrieve data from the website on their computer screen, print individual pages on paper, photocopy and store such pages in an electronic form on disk (but not on any server or other storage device connected to a network) for their exclusive personal use only.

(x) Registered User and the Visitor agree not to use, transfer, dispose or disseminate of any information contained in the website in any manner that could compete with the business of Optima Insurance Brokers Pvt. Ltd. or otherwise compromise or imperil the interests of Optima Insurance Brokers Pvt. Ltd..

(xi) Registered User and the Visitor shall not Reverse engineer, decompile, disassemble, copy, reproduce, distribute, modify, transmit, perform, reproduce, publish or create derivative works from or in any way exploit any of the services or content in violation of the Terms and Conditions or the laws of any country.

(xii) Registered User and the Visitor shall not create a database in electronic or structured manual form by systematically downloading and storing all or any part of the Web Site save and except such information as relates to his Policy, if he is a Registered User.

(xiii) Registered User and the Visitor shall not rent, lease, sell, sublicense, or lend your access to the website.

(xiv) Registered User and the Visitor shall not Cache or permit caching by any person.

(xv) Registered User and the Visitor shall not engage in any fraudulent, abusive or illegal activity, including but not limited to any communication or solicitation designed or intended to fraudulently obtain the password or any private information of any use.

(xvi) Registered User and the Visitor shall not use the website to violate the security of any computer network, crack passwords or security encryption codes, transfer or store illegal material including threatening or obscene material or engage in any kind of illegal activity.

(xvii) Registered User and the Visitor shall not run mail list or any form of auto-responder, or spam on the Web Site or any processes that are run or are activated while you are not logged on.

The Top Product mentioned in the website will be based on a comparison of various like products including its features and claims made on the basis of the evaluation by Optima Insurance Brokers Pvt. Ltd. and its personnel or as a mode of canvassing for the top product as mentioned.

6. RENEWAL

Registered Users have the option to renew the policy online. The Registered Users should issue renewal instructions online no less than 7 working days before the expiry of the policy. Optima Insurance Brokers Pvt. Ltd. and its personnel shall not be responsible for any expiry/lapsing of the policy. Any change from the original data as provided should be upgraded in the website so as to avoid any errors while renewing the policy.

7. OTHER SERVICES

Optima Insurance Brokers Pvt. Ltd. may from time to time provide other services which may be duly notified on the website. To start with Optima Insurance Brokers Pvt. Ltd. will provide free claims assistance to its users but it shall not mean and be construed as an approval and payment of the claim by the Insurance Company. Optima Insurance Brokers Pvt. Ltd. and its personnel shall not be responsible for any delay, part payment or non payment of the claims to the users by the Insurance companies.

8. FORCE MAJEURE

Optima Insurance Brokers Pvt. Ltd. and its personnel shall in no way be held liable for any failure to perform any of its obligations if the performance is prevented, hindered or delayed by a event of Force Majeure. Any event of Force Majeure shall mean any event due to any cause beyond the reasonable control of the Party, including, without limitation, unavailability of any communication system, sabotage, fire, flood, explosion, acts of God, civil commotion, strikes or industrial action of any kind, riots, insurrection, war or acts of government. The Obligations and liabilities of Optima Insurance Brokers Pvt. Ltd. and its personnel shall be suspended for so long as the Force Majeure Event exists and continues save and except any event of Force Majeure shall not prevent the accrual of interest on a principal amount which would have been payable by the user but for this provision.
